We hereby submit specifications and estimate for:

Application of algaecide, Cutrine Plus or similar, in Valley Shores HOA lake, to treat algae. Cutrine Plus is a chelated copper liquid. Bid price is for one “whole lake” treatment which may require more than one application depending on severity of algae growth when treated. Water temperature must be above 65 degrees Fahrenheit before treatment can take place.

Bid Price per Treatment: \$2,250.00

Be aware that algaecides are not a permanent fix. More than one treatment is usually required during a normal growing season. Treatments will be scheduled as requested by Valley Shores HOA. Invoice will be sent and payment due upon completion of each treatment.

Job Description: Aquatic Herbicide Application

We hereby submit specifications and estimate for:

Application of herbicide, Reward, in Valley Shores HOA lake, to treat submersed aquatic plants. Reward is a contact herbicide and will kill plants that are actively growing. For this reason, a second treatment may be required to keep the lots weed-free throughout the growing season. If a second treatment is required, the price will be one-half (50%) the initial bid price. Included in this bid is cost for chemicals and labor to apply. Expect 7 to 10 days for knockdown. Please note: do not drink water treated with Reward for three days (domestic animals one day) after application. Do not use water treated with Reward for watering trees, shrubs, grass, etc. for five days after application.

Bid Price: \$3,200.00

Initial treatment will be completed in May, 2023 (exact date to be determined). Invoice will be sent and payment due upon completion of each treatment.
